**UFCW PLAN "D" PRESCRIPTION DRUG CHANGE EFFECTIVE JANUARY 1, 2011**

Due to the Healthcare Reform, the United Food and Commercial Workers ("UFCW") & Employers AZ Health Fund's co-pay for brand drugs purchased at a SSA Mexico Provider will be reduced from the current \$15 to \$8 per RX is effective January 1, 2011.

This does not change the limitation that there is no coverage for brand name drugs purchased when there is a generic substitute available. If a claim is submitted for brand drug and there is a generic substitute the claim will be denied. This limitation was effective April 1, 2010.

Notice of this change is being mailed to **ALL PLAN D** participants on December 28, 2010.
